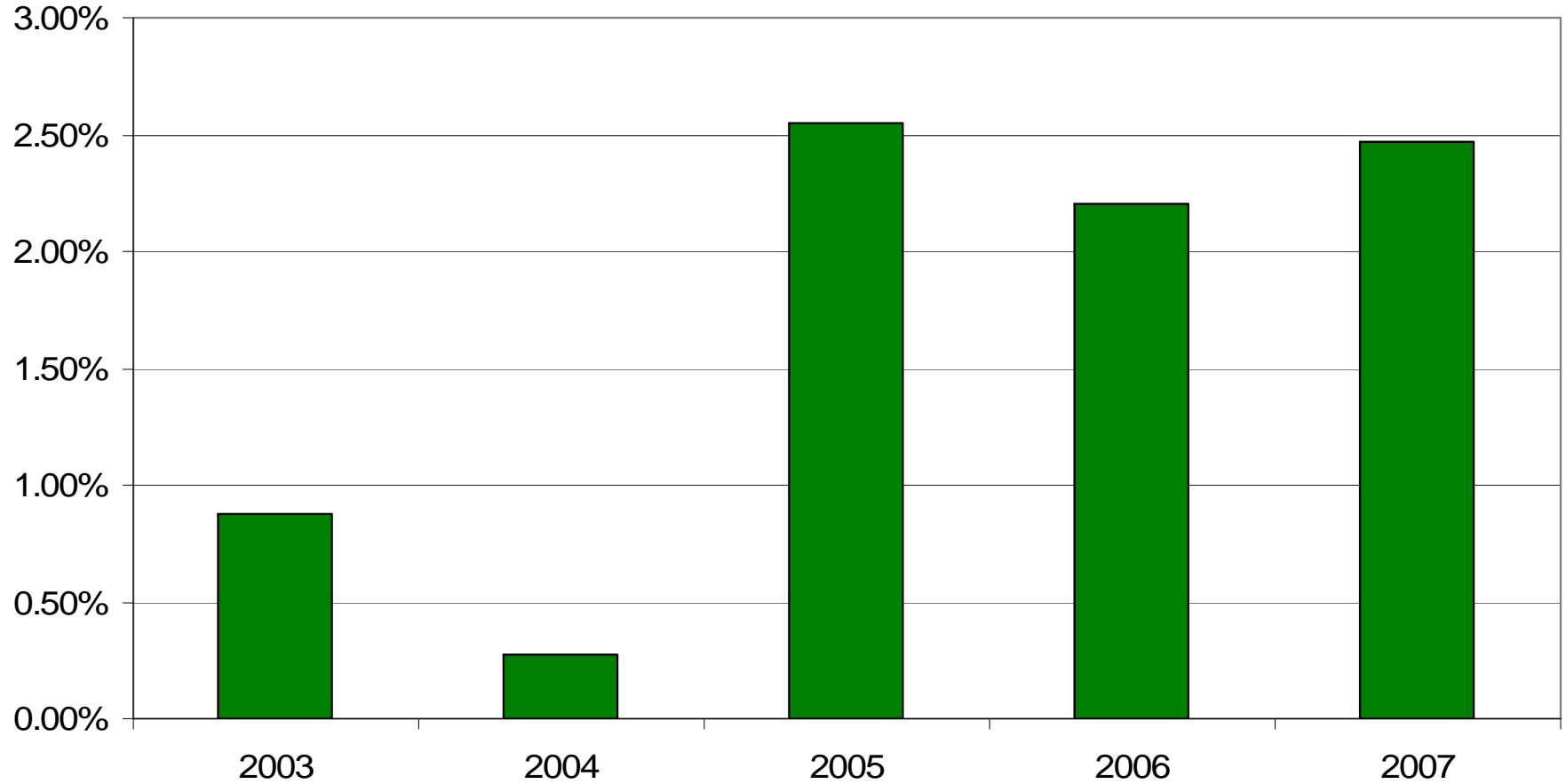

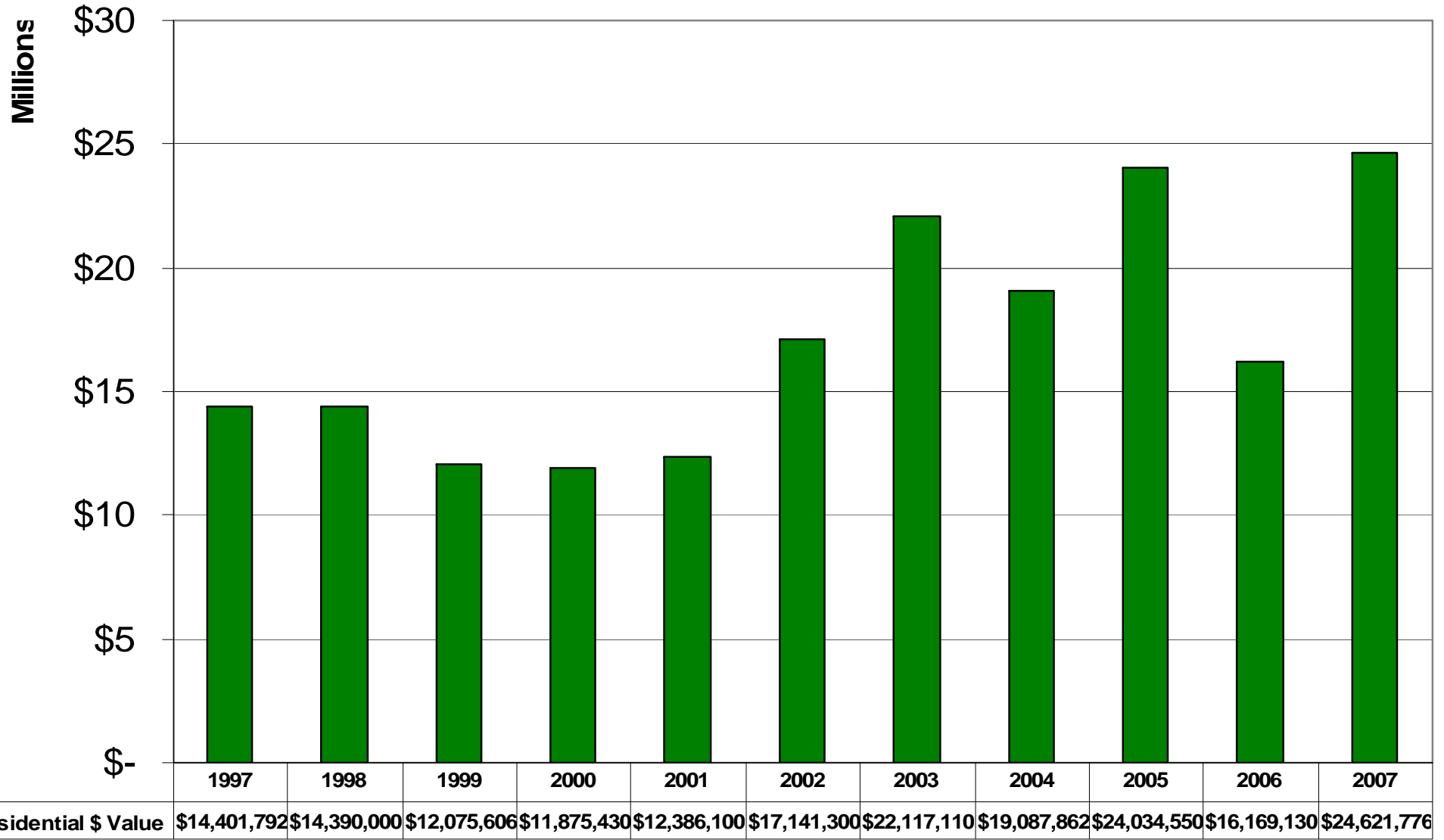

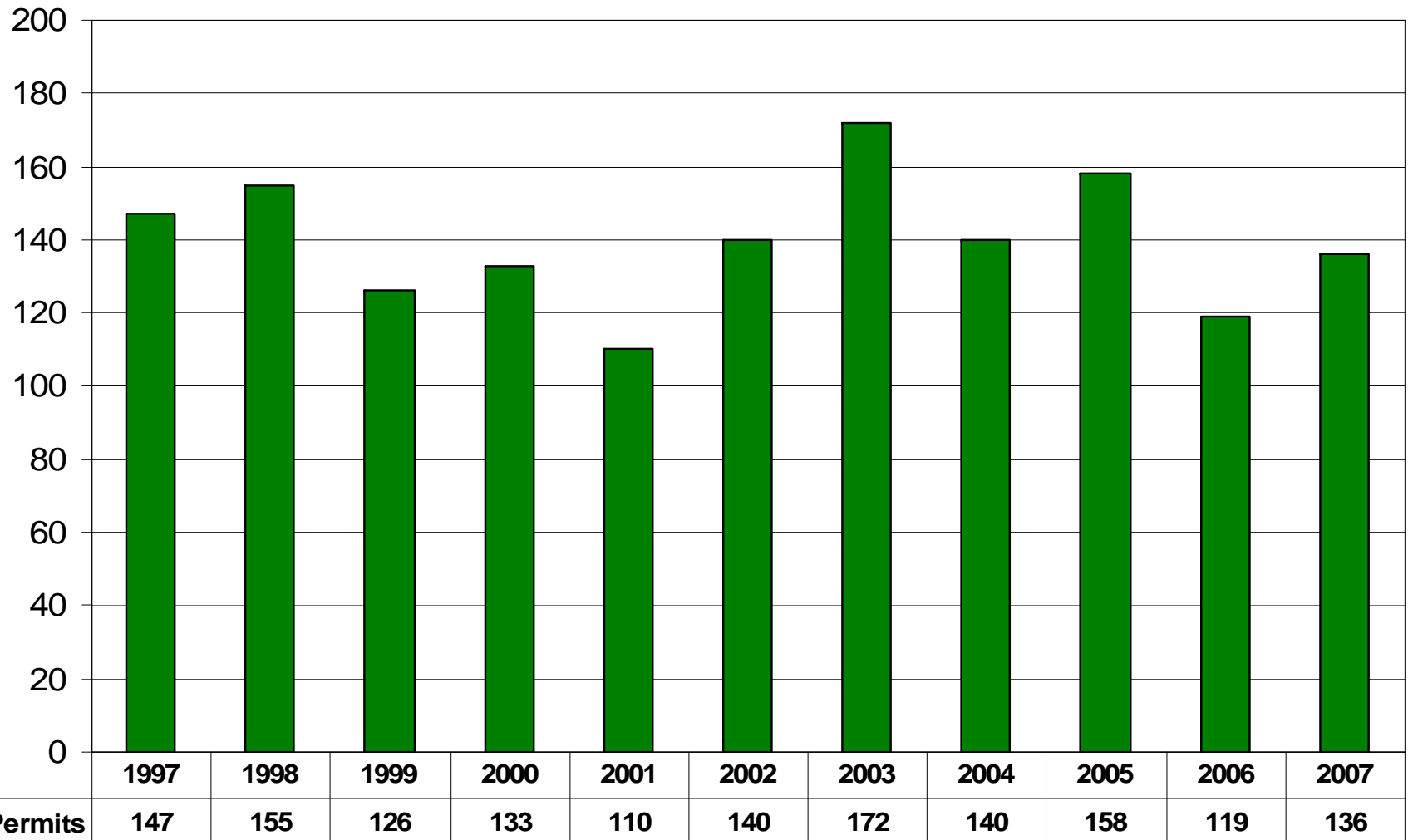

# City of Van Buren Residential Building Permits - # of New Residential Permits

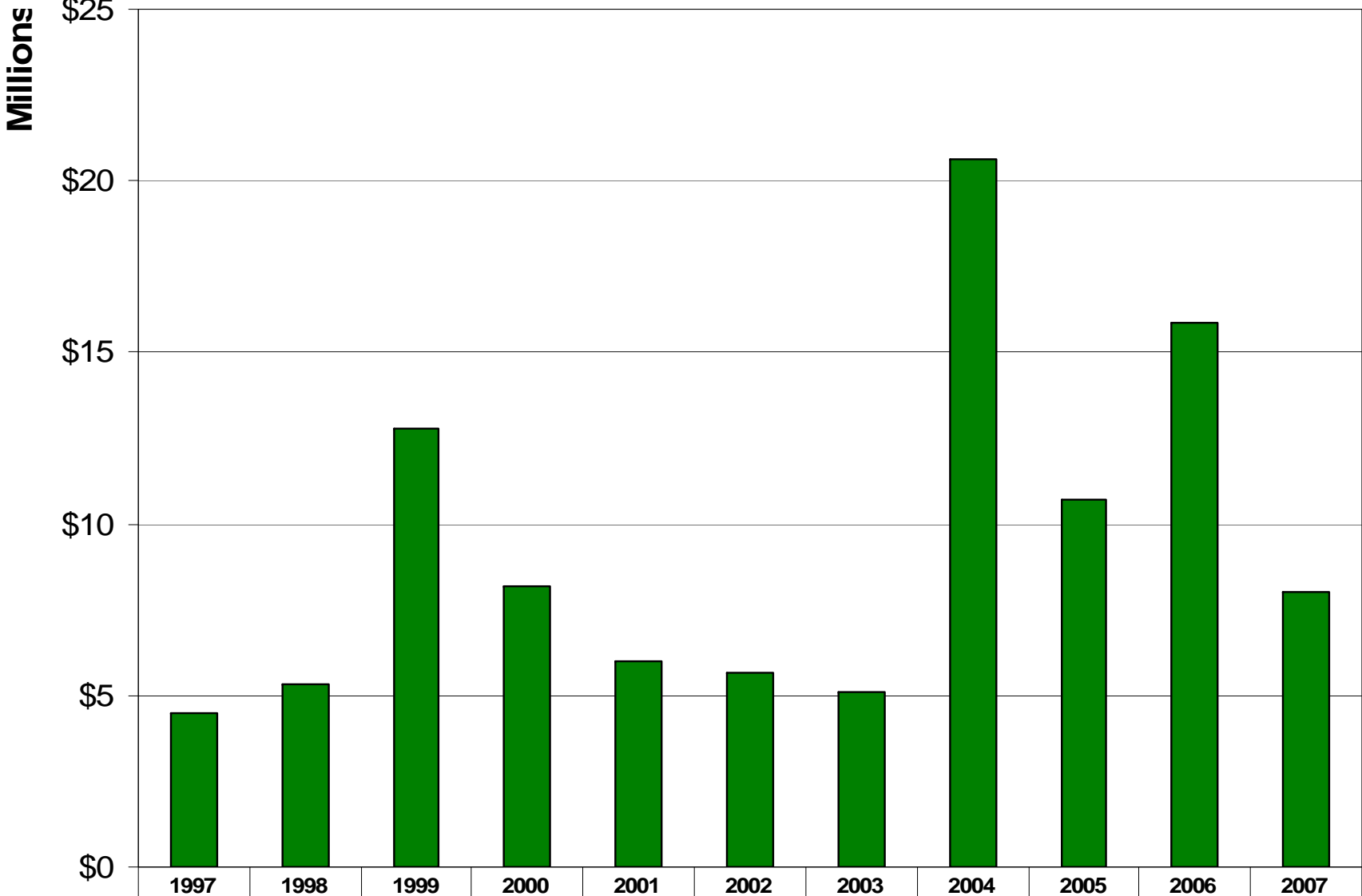

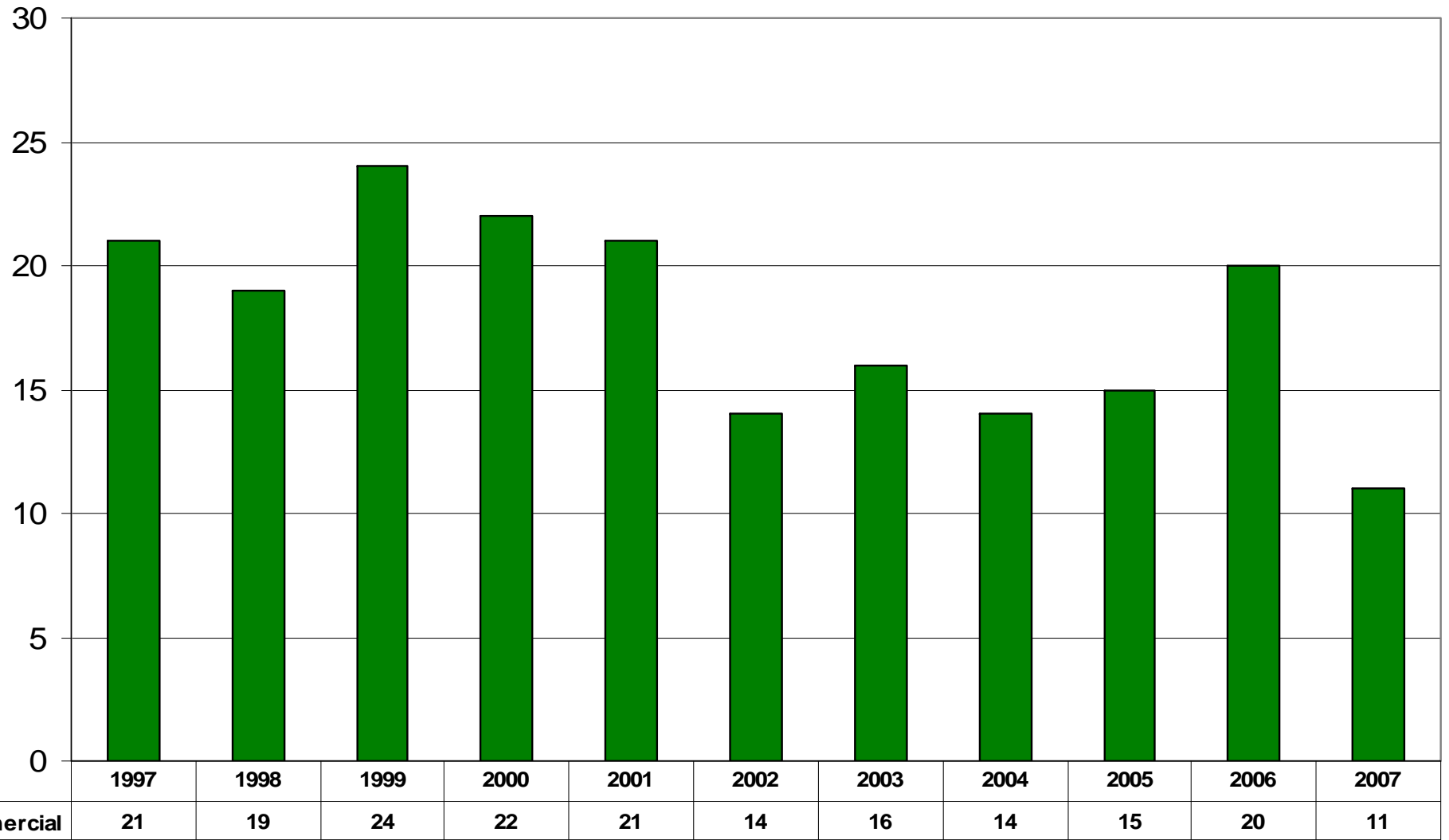

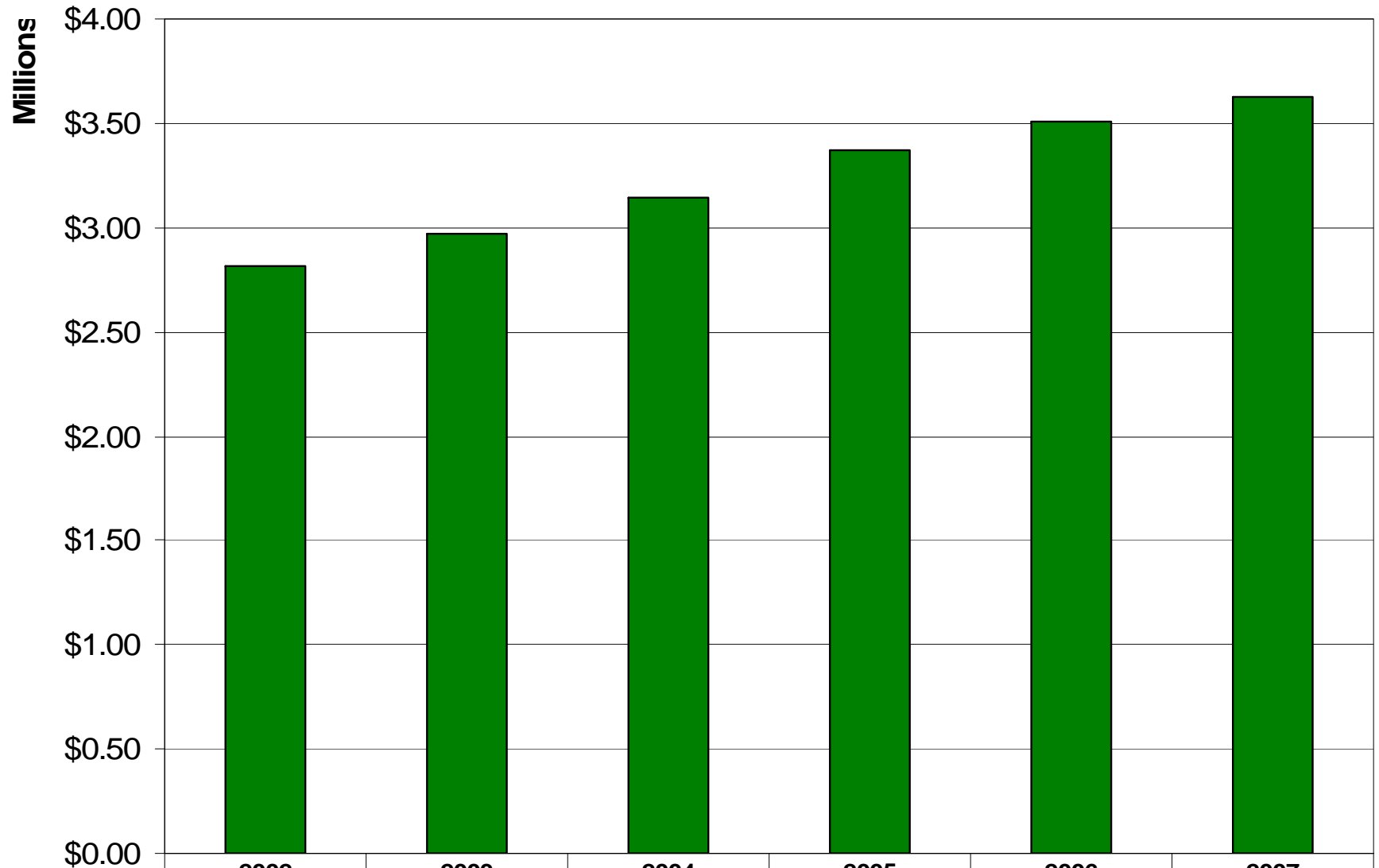

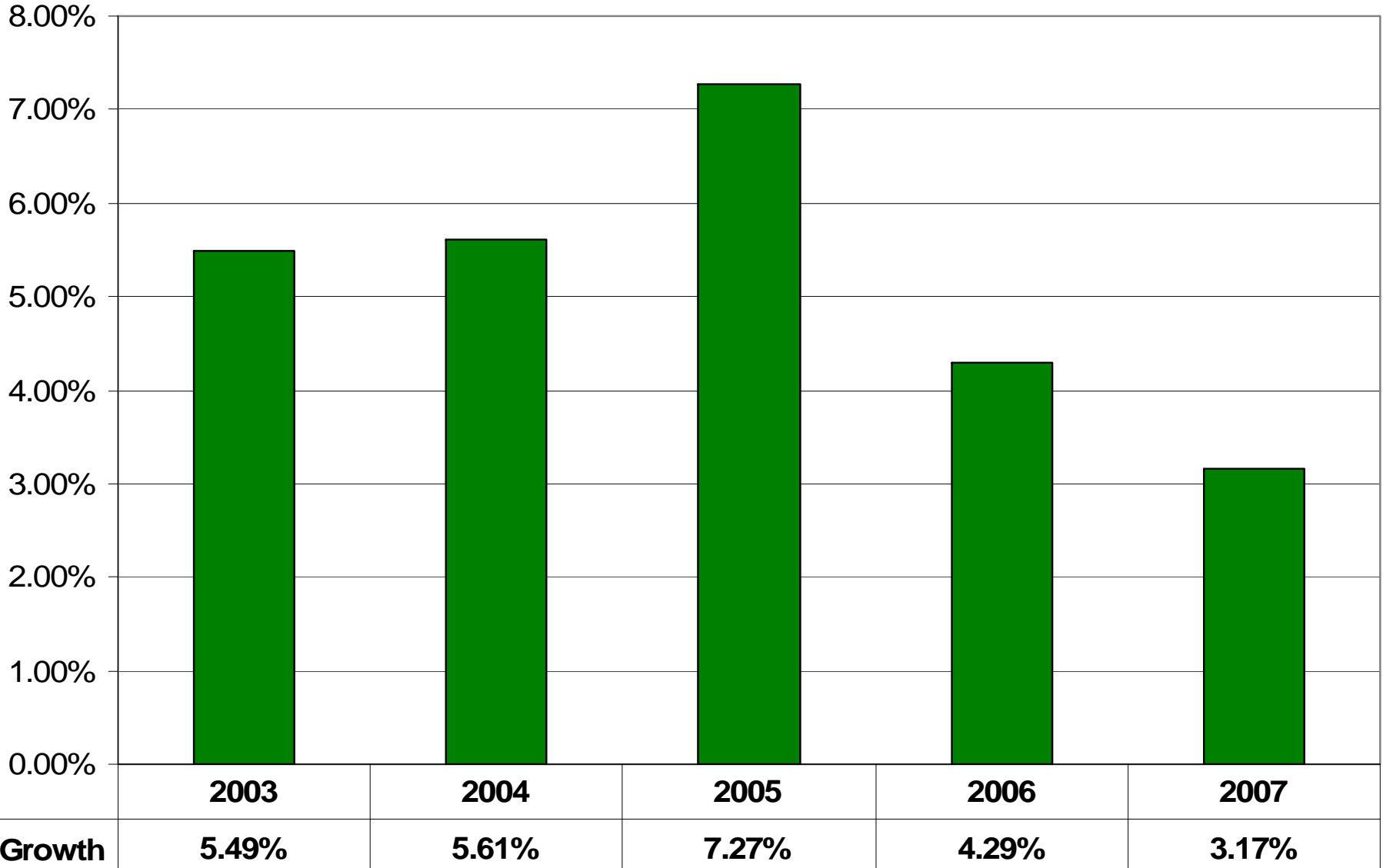

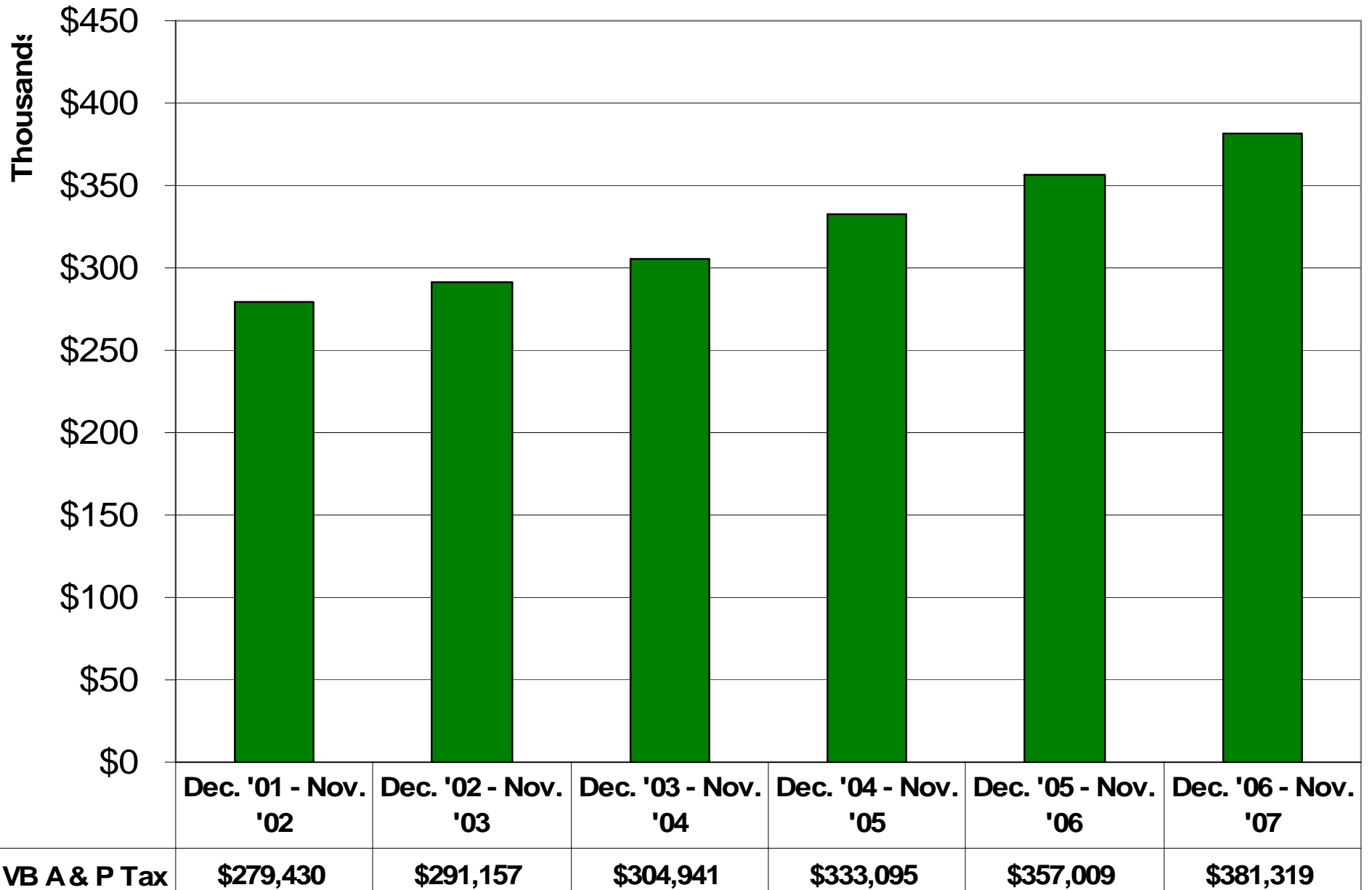
# Van Buren City Sales Tax Collected - % of Growth

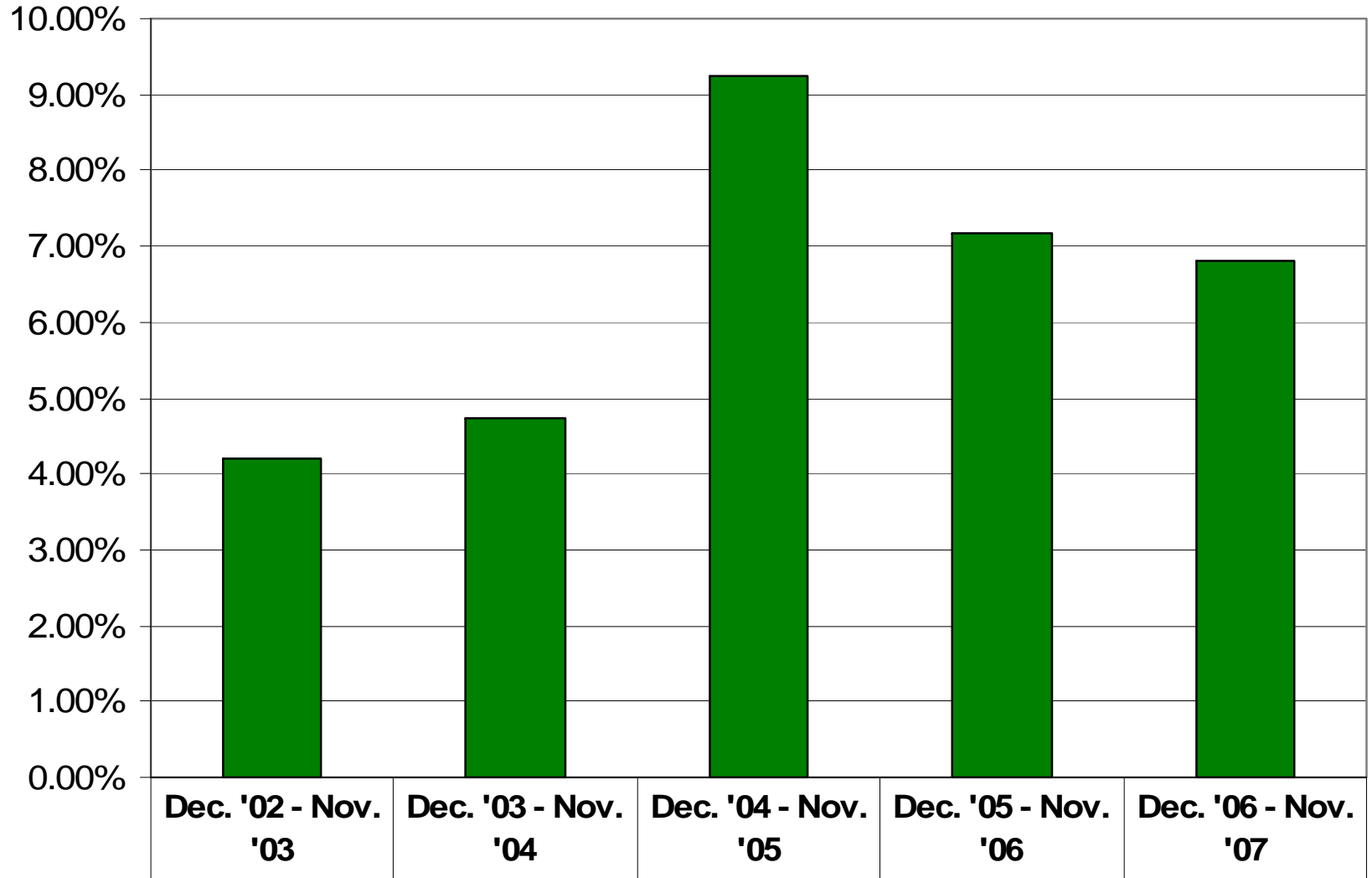

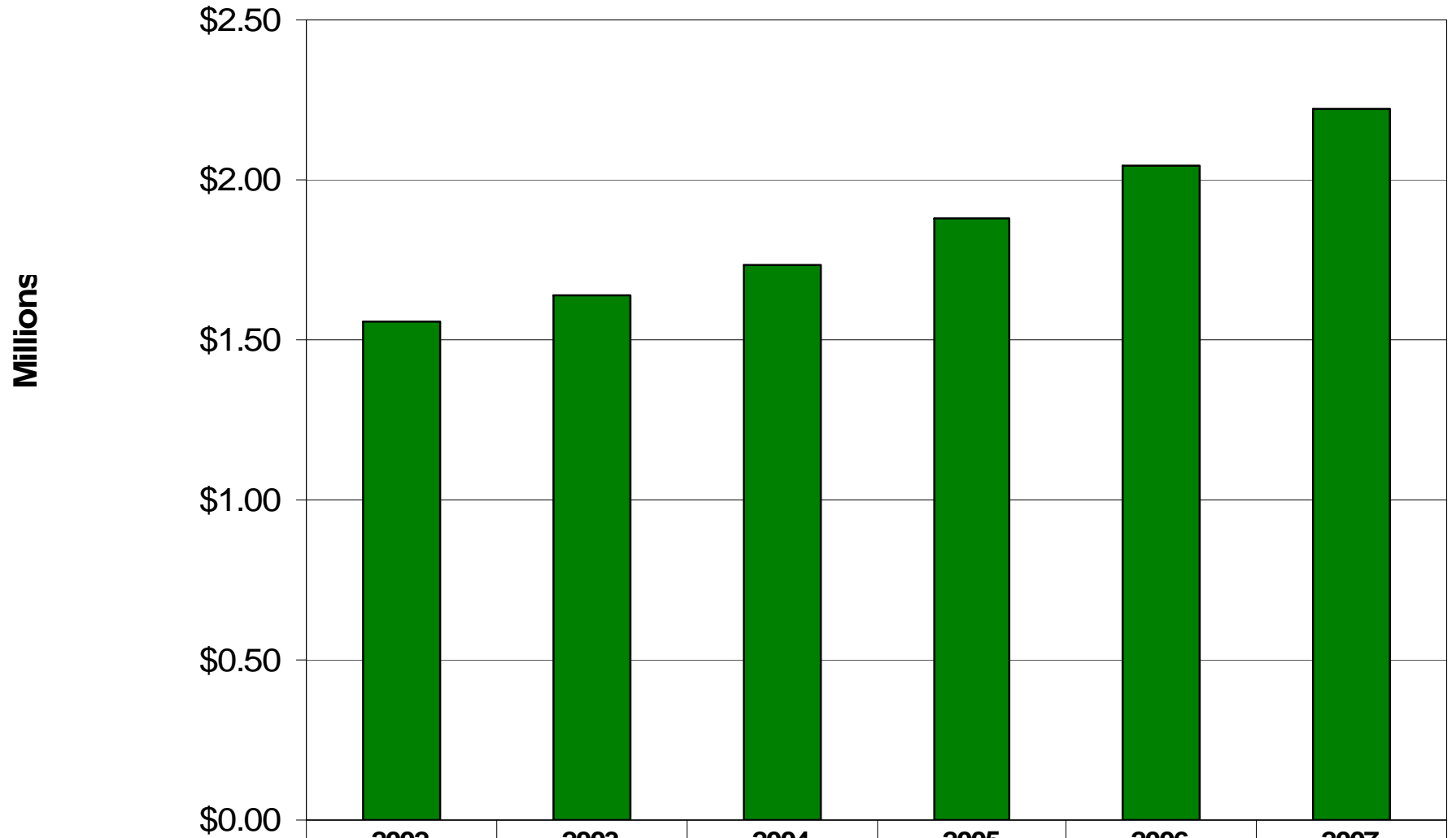

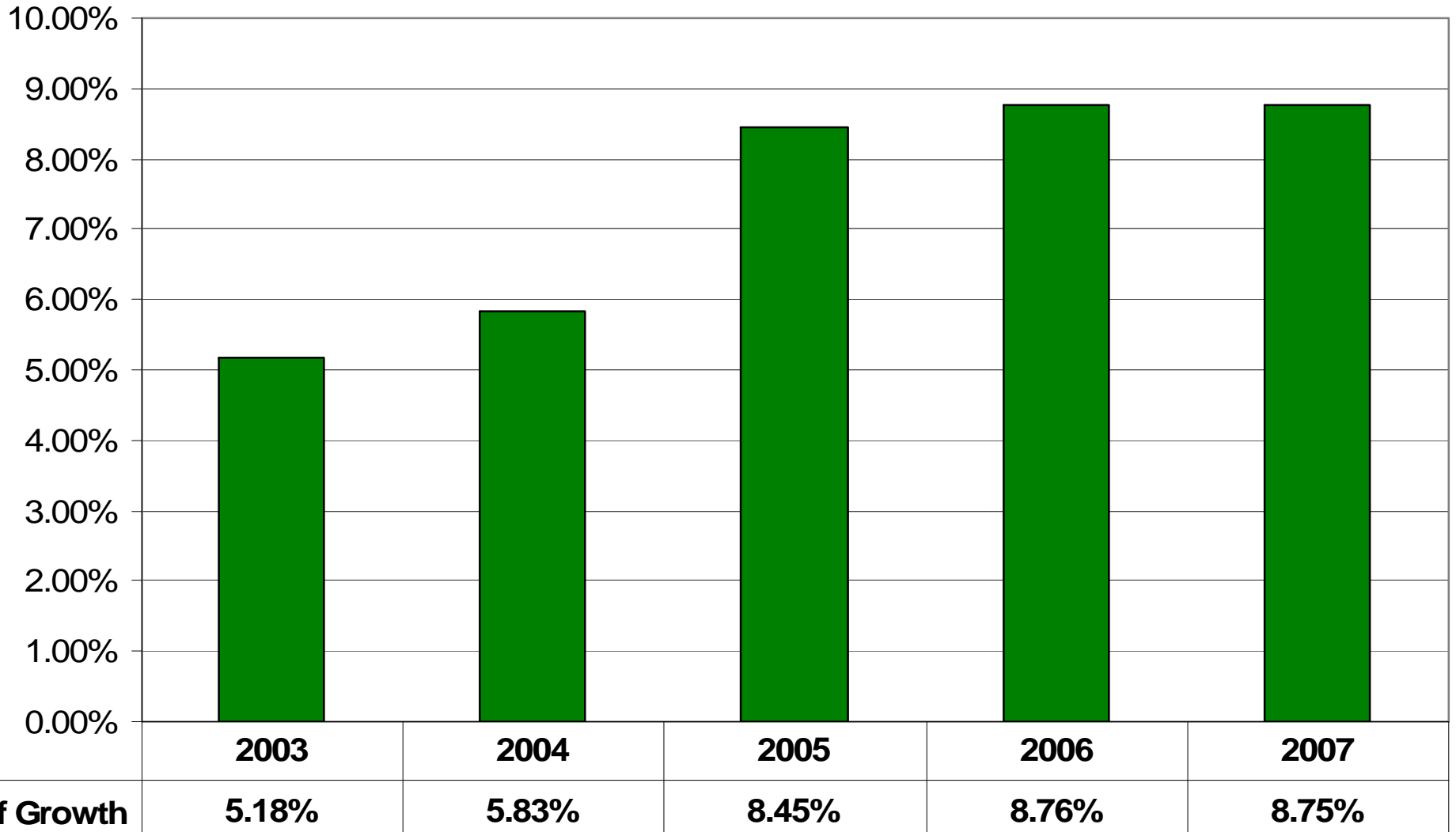

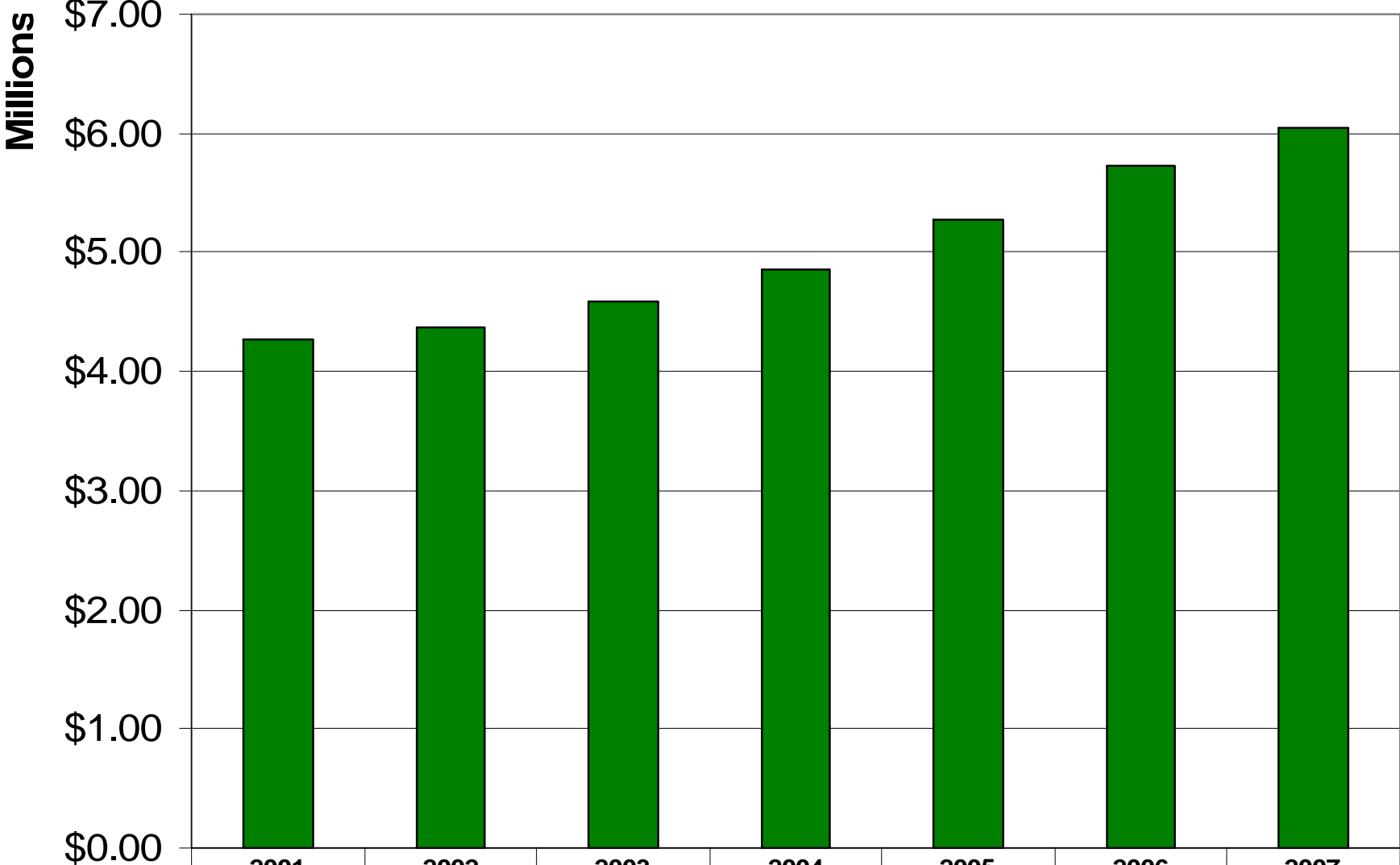
# Van Buren's Portion - Crawford County Sales Tax Collected - % of Growth

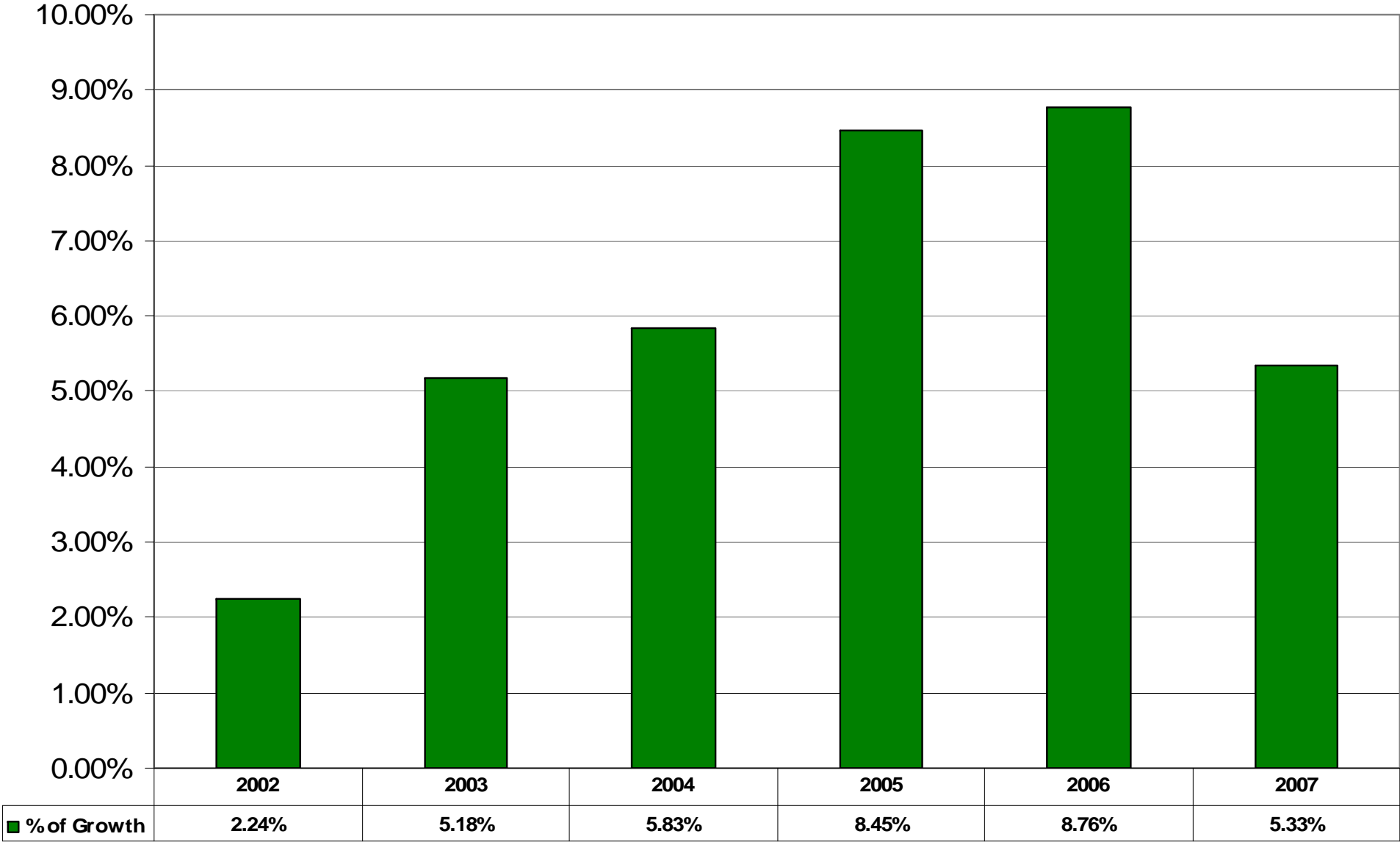

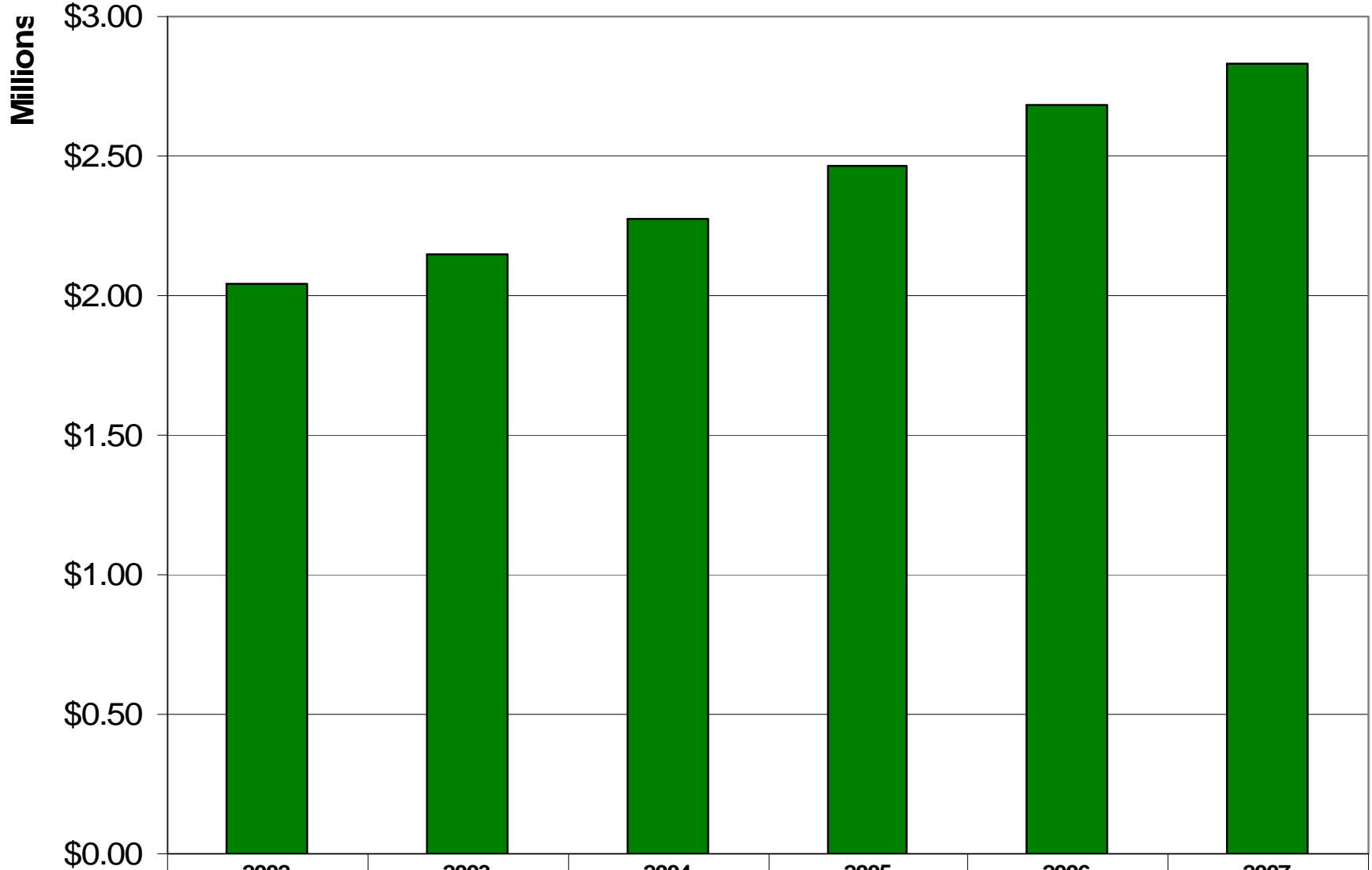
# Total Crawford County Sales Tax Collected - % of Growth
